## **ELIGIBILITY TO BE ELECTED INTO THE BOARD OF DIRECTORS AND SUPERVISORY BOARD**

**The eligibility criteria shall be in compliance with Fundilima HOUSING Cooperative Society Ltd bylaws as follows: -**

A person shall be eligible for membership of the Board of the society or remain a member of the Board if: -

- a) Is 18 years of age and above.
- b) Is able to read and write and/or has attained ordinary level of education or its equivalent.
- c) Does not receive any remuneration salary or any other payment from the co-operative society save in accordance to the Act.
- d) Is not a Board member in two other co-operative societies.
- e) If he/she is not a member of a co-operative society that sells land to its members, sells land on his own company.
- f) If he/she is not a member of a co-operative society which trades in goods or produce, trades either on his own account or some other persons account in the same type of goods or produce.
- g) Has within thirty days of being appointed declared his wealth with the Commissioner in the prescribed manner.
- h) Is not an undercharged bankrupt.
- i) Is not of unsound mind.
- j) Has not been adversely named by the Commissioner in an inquiry report adopted by a general meeting for mismanagement or corrupt practices while a member of a Board.
- k) Has not been convicted of any offence involving dishonesty or is sentenced to imprisonment for a term exceeding three months.
- l) Has not been convicted of any offence under the Act or Rules made thereunder.
- m) Does not have any uncleared debt owing to a co-operative society at the end of its financial year other than in respect of a land debts under the provision of any rules made under the Act.
- n) He/ She is not a person against whom any amount of money is due under a decree, decision or is pending recovery under the Act.
- o) Is an active member of the society and whose monthly savings and land repayments have been contributed to the society for a period of three months.
- p) He/she has been a member for a period not less than 24 months.

Do hold a minimum non-withdrawable shares of Kshs. 170,000/ (Kenya Shillings One Hundred and Seventy Thousand) in the Society at the time of seeking election or have acquired at least one fully paid and existing project with the society at the time of seeking election
